4. <u>Assumption of Risk:</u> I understand that the services I provide to Nonprofit may include activities that may be hazardous to me inducing, but not limited to lifting, climbing, bending, standing, or walking or any other inherently dangerous activities. As a volunteer, I hereby expressly assume the risk of injury or harm from these activities and release Nonprofit from all liability for injury, illness, death or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services.
5. <u>Photographic Release:</u> I grant and convey to Nonprofit all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by Nonprofit in connection with my providing volunteer services to Nonprofit.

Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Kansas and that this Release shall be governed by and interpreted in accordance wit the laws of the State of Kansas. I agree that in the event that any cluse or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
