### Volunteer Kansas accepting Seed Grant applications

WICHITA – For the ninth consecutive year, Volunteer Kansas is offering organizations in Kansas the opportunity to apply for \$500 Seed Grants to support service projects that will engage volunteers.

Ten grants will be awarded in May for use before Dec. 31.

The application process is simple. Organizations interested in applying for a grant should email the following information to contact@volunteerkansas.org by April 30:

The name address, website, and phone number of the organization, along with applicants name, title, email and phone number; a paragraph about the organization; one- to three paragraphs explaining the project you wish to fund, how volunteers will participate and who the project will benefit; and a budget detailing how the money will be used.

Projects chosen for grants require listing as volunteer opportunities on www.volunteerkansas.org. Projects must utilize at least 20 volunteers.

Winners are required to post project photos/videos to the Volunteer Kansas Facebook or Twitter pages with #comeandgiveit, #volunteerkansas.

#### New report lists Mount Hope Nursing Center among best in state

MOUNT HOPE – The Kansas Foundation for Medical Care Inc. has listed Mount Hope Nursing Center among the top 10 percent of long-term care facilities in the state.

In fact, the agency's score put it in the top 7 percent of the hundreds of Kansas' long-term care facilities.

The score is determined by assessing more than a dozen National Quality Forum-endorsed long-stay quality measures that represent systems in the long-term care setting.

Some of the quality areas assessed include such important matters as injuries from falls, patients in pain, residents with depressive symptoms, weight loss and other medical issues that can occur in a long-term care facility.

"At Mount Hope, our staff works diligently to ensure all our residents are safe, healthy and provided a wealth of opportunities to be social and active," said Mount Hope Administrator Gina Terry. "We are proud that our efforts are reflected in this prestigious report, but more

#### SBA announces Technology and Manufacturing cluster initiative at K-State

MANHATTAN — The U.S. Small Business Administration has announced the addition of the Great Plains Technology and Manufacturing Cluster to the programs it supports through the nationwide Regional Innovation Clusters initiative.

The program has been awarded \$500,000 for the first year with a four-year option for a total award of up to \$2.5 million over five years.

The Great Plains TMC is led by the Kansas State University Technology Development Institute. It serves the entire state of Kansas and western Missouri and joins a portfolio of programs supported through the SBA's Regional Innovation Cluster program.

The program is designed to support geographically concentrated groups of interconnected businesses, suppliers, service providers and related institutions in a particular industry or field. The goal of this new initiative is to assist manufacturers and technology entrepreneurs, particularly in rural regions, in making the critical connections to innovation resources required to protect, develop, launch and grow new products and businesses in the service region.

The Great Plains TMC is partnering with a wide range of economic development entities, including the Kansas Department of Commerce, NetWork Kansas, the Kansas Small Business Development Centers and a number of rural regional development offices across the service

region to increase awareness, connectivity to resources and collaboration across the Great Plains.

"Whether it be education, engineering, business planning or a combination of all these, our mission is to ensure that individuals and organizations are aware of and have access to the resources available to assist them," said Jeff Tucker, executive director of the university's Technology Development Institute.

#### U.S. Department of Labor's overtime proposal open for public comment

WASHINGTON, DC – The U.S. Department of Labor announced Friday that the Office of the Federal Register has published the Department's Notice of Proposed Rulemaking that would make more than a million more American workers eligible for overtime under the Fair Labor Standards Act (FLSA).

The official publication in the Federal Register marks the start of the proposal's public comment period, which will remain open for 60 days and close on May 21.
